### **First Nations Community Healthsource - EAST**

First Nations Community Healthsource (FNCH) Education and Advocacy against Sex Trafficking (EAST) is dedicated to supporting Native American/Alaskan Native victims of human trafficking and all underserved populations including women, men, LGBTQ+, and youth who are living in Albuquerque, New Mexico area, and Tribal communities. The EAST program provides advocacy, prevention education, and essential case management services to victims by linking them to resources and services.



### **Indigenous Women Rising**

Indigenous Women Rising creates the space for us as indigenous people to tell our own stories on our terms as an act of resistance, self love, and love for our ancestors and family. We reclaim what colonialism and white supremacy have tried to strip from us: identity, culture, tradition, and language.



### **Missing and Murdered Diné Relatives Coalition**

Through the leadership of Council Delegate Amber Kanazbah Crotty, in March 2019 a working group was established to begin addressing the ongoing crisis of missing and murdered relatives on the Navajo Nation. The group is comprised of a multidisciplinary team tasked with developing a framework to establish a Missing & Murdered Diné Relatives data institute, encourage community action, and develop a missing persons community action toolkit to empower Navajo communities to be proactive in prevention, awareness, and mobilization to recover missing relatives and to provide support to families of MMDR.

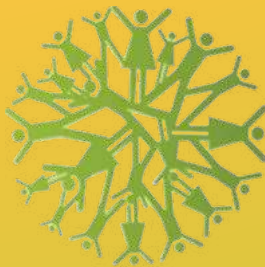
### **Native American Professional Parent Resources (NAPP)**

NAPP provides support to our Native American communities through: Albuquerque Area Dental Support Center, Early Intervention, Early Childhood Services and Tribal Home Visiting.



### **NMDOH - Tribal Overdose Prevention**

The New Mexico Department of Health ensures health equity, working with our partners to promote health and well-being and improve health outcomes for all people in New Mexico.



### **Outcomes, Inc.**

Outcomes was founded in 1951 on the premise that families are the most precious resource in our community. Our first programs supported families and we continue to do so with our individual and family counseling. Over the years we have expanded our work to assist people in need of conflict resolution, employees in the workplace, and grandparents raising grandchildren.

### **Planned Parenthood - The Native Community Health Network**

The Native Community Health Network (NCHN) is a community health worker program that is geared to work with Indigenous communities in the Southwest. NCHN started in 2019 and specializes in sexual and reproductive health education, advocacy, outreach, and linkage to essential resources. Their team of Community Health Workers are certified to perform Rapid HIV testing and are trained as Harm Reduction specialists in the state New Mexico. Their office is based out of Albuquerque, NM (occupied Tiwa territory) and they offer programming in and around the four corner states.



### **Presbyterian Health Plan**

The Native Community Health Network (NCHN) is a community health worker program that is geared to work with Indigenous communities in the Southwest. NCHN started in 2019 and specializes in sexual and reproductive health education, advocacy, outreach, and linkage to essential resources.



### **Pueblo Action Alliance (PAA)**

Pueblo Action Alliance is a community driven grassroots organization that protects Pueblo cultural sustainability and community defense by addressing environmental and social impacts in Indigenous communities.

### **Sexual Assault Services of Northwest New Mexico**

Rape Crisis Center that provides Sexual Assault Nurse Exams, Advocacy, Therapy, & Education/Prevention/Outreach awareness. Provides services in tribal communities in rural areas in Northwest Four Corners Region.



### **Southwest Women's Law Center**

The mission of the Southwest Women's Law Center is to create opportunities for women to realize their full economic and personal potential. We work with the intention to eliminate gender bias, discrimination, and harassment. We lift women and their families out of poverty, and we ensure all women have full control over their reproductive lives through access to comprehensive reproductive health services and information.



### **U.S. Drug Enforcement Specialist**

U.S. Drug Enforcement Administration's Operation Engage initiative supports local drug-free coalitions by raising awareness on drug threats such as methamphetamine, illicit fentanyl, and fake pills.



### **Utah Navajo Health Systems**

Utah Navajo Health Systems provide victims services in the NM, four corners area. Utah Navajo Health System, Inc., started in 2000 as a single service corporation providing medical and dental care needs for rural communities in southeastern Utah. In September 1999, the Navajo Utah Commission recommended that the local community manage the health care services in the area.

Peggy L. Bird is of the Sun Clan from Kewa Pueblo, New Mexico. She is a mom, grandmother, an advocate/attorney/consultant/human rights activist and works to enhance the sovereignty of indigenous women by ending violence against Native women, both nationally and internationally. She provides training and technical assistance to address violence against Native women and also facilitates comprehensive strategic planning sessions with a Native perspective. Peggy is a co-founder of the Coalition to Stop Violence Against Native Women, Inc., and the Indigenous Women's Human Rights Collective, Inc. She is a board member of Tewa Women United, Inc., the National American Indian Court Judges Association, and a co-founder of the NCAI Violence Against Native Women Task Force. She is a recipient of the U.S. Department of Justice National Crime Victims Service Award and the Sunshine Peace Award granted by the Sunshine Lady Foundation and the National Coalition Against Domestic Violence. She received her Juris Doctorate from the University of New Mexico School of Law in May 1990, became a member of the State Bar of New Mexico in October 1990, and in May 2018, she received her Doctorate of Philosophy from Arizona State University.
